

Ruskin, Jan. 11, 1916.

The Ex. Com. met at the home
of L. L. Dickman. As it was
the first meeting held since
the election of Common Good
officers, the Com. proceeded to
organize. L. L. Dickman was
elected chairman.

The contract for the sale
of the undivided half of the
two acre tract of land in S. 1,
was taken up and the terms
agreed upon after making
one or two changes with the
consent of the purchaser in
behalf of the college, Dr. Miller.
The contract was then ackn-
owledged before Mr. Buckland,
Notary. After an informal
discussion of several matters
concerning the welfare of the

Ruskin, Fla. Feb. 4, 1916.

The Ex. Com. met at the Common
Good office, three members
present. Mr. McKinley, Road
supervisor, presented bill for
road work amounting to
\$1.25. The bill was allowed
and an order drawn in full
tendency for the amount.
An order was also drawn
for the amount of \$1.25, for
the same purpose.

Feb. 4, 1916.

Ex. Meeting. Mr. McKinley, road
supervisor, presented bill for
road work amounting to \$11.25
Bill allowed and order drawn
on the treasurer for the amt.
Order was also drawn on the
treas for 30 cts. for the purchase
of order books for Sec. Treas
and Road Supervisor.

Executive Meeting.

May 4, 1917.

Meeting called for the purpose
of considering a letter from
Mrs. Doane, asking for
bottom price on land - 5 ac
in west 80, and also asking
about 10 a, tract on N. side
near Bay Shore Road.

The Ex. decided to recommend
that Mrs. Doane be offered
20 lots (5 a) in the W. 80,
for \$450⁰⁰ which is a
discount of 50% on the
special price already being
made on these lots.

Mr. Ester made the
following offer for E. half of
10 a tract 207-5a -
\$30 in ditching and taxes on his
3 lots \$30 cash in 9 mos.
\$30 " " 18 mos.
making 90 for the 5 acres.

The Ex. did not recommend
selling the 5 acres at the
price offered.

Apr. 4.

Executive committee met
and elected L. H. Dickman as
chairman and Mrs Ruth Miller
secretary.

Oct 8.

Meeting called to order by
chairman.

Motion that Mr. Walker
be consulted relative to
digging a ditch on the
north side of inlet, and if
he can possibly do it - to
have it done

Seconded and carried.

Adjournment.

Executive Dec 10, 1923.

Moved and carried that Mr. Barnes be instructed to pay sums for wood to the Sec. of the Common Good, that being the regular channel.

Moved that we recommend that the C.G. appropriate \$5.00 for the use of Mrs. Goodenough in having the clearing done again on her street.

Recommended that we sell down timber from C.G. land, asking 35¢ per cord, and reserve the standing timber.

Request Mr. Blackland to give Mr. Barnes receipts for the sums paid by him for wood.

Feb. 28, 1924

Moved that Mr. Vitmer be asked to check up on the wood cut by Mr. Barnes. Carried.

Apr. 3, 1924

Willie Walker was elected chairman of the Ex. Com.

Suggested that the chairman stir up the new Treas. urging him to qualify at once.

Street planting of trees was discussed.

Sec. was reminded to send receipt to Mrs. Lipscomb for \$10 paid by her for Com. lot.

Dec. 3, 1924

Members of Ex present also
Messrs Paul Dickman and Alvin
McHargue.

After discussion it was
agreed to recommend to the C.G.
that it appoint a Com. to go into
the matter of C.G. lots as to
number and value, and to
confer with Paul Dickman
in regard to the proposition
he wishes to make in regard
to ditching and grading
Ruskin streets in exchange
for unsold C.G. lots. The
Com. to be asked to attend to
the matter at once and
report at a special meeting
to be called in two weeks.

Decided that the long discussed
signs be made for Ruskin
Mrs. Miller to see Mr. Curry
about painting the signs.
Adjourned.

Jan 2.

Executive meeting, all present
Request of A. P. Dickman that
lot #305 be dedded to Pauline
McHargue, and of L. L. Dickman
that lot 550 be dedded to Reec
Dickman was reported.

As the Day Book shows that
both these lots have been paid for
it was agreed that to recommend
that the Trustee of Record be
instructed to make the deds.

The executive further reports
that it has granted to D. D. Esten
permission to build and

operate a garage on Ruskin Inlet
near his store for five years.
Interested to plant trees and do
other work in consideration of
this privilege. Adjourned.

Jan. 7, 1925 - Executive Meeting.

The executive committee met
and chose Mr. Waters for
chairman. It was decided
to have the auditing com.
see that the ~~claims to certain~~
~~lots was~~ lots ^{for} ~~which~~ ^{deeds} had been
asked, were fully paid for.

Feb. 4, 1925;

1 Executive Com met and
is ready to report that a deed
had been made to Willie
Walker for the N. 80. and the
mortgage for the amount
still due on the land is
at the recorder's office with the
deed.

Reports that by the advice of
a number of members, a permit
was granted to Mr. Bolin, for
the building and operating of
a Sea Room on the lot he had
just purchased. *86 adopted*

Reports the drawing of an
order on the treasury for \$33.60
toward paying for a page ad. in
the Florida Grower's special feature
edition to be ready for distribution
during the fall. *adopted.*

Reports that Mr. Barnes offers
to C.G. 50¢ a stick for piling

timber. 7-8 in. at small end.
Ex. Com. thought this matter
had better be decided by the
C. G. itself. Offer refused

It has been reported to the
Ex. Com. that Mr. Dickman
has offered to furnish lumber
if the C. G. will build a bridge
on the boulevard just below
his house.

Harry Spencer presents the
following bill for work done
on the streets and ditches
out near his house. Mr.
Spencer asks for \$175.00
in payment for this work.
Has the lot been appraised?

Reports that Miss Orcutt
has deeded to the C. G. the
S. part of her home place for
a park, reserving for the 20th.
Cent. Club, a site for club house.
It was the sense of the Ex that
the ground should be cleared
up as soon as possible, and
asks that the C. G. call for a
bid to do the clearing.

X Feb 4, 1925-

Executive meeting, 2 members
present. Reports having deeds made
to Pauline McHargue, and Ruel Dickie
and Mr McKinley as voted in the
Jan meeting, and has drawn
order on the treasury for \$150 for
making of deeds. Ex recommends
a bid for cleaning up grounds of
park given by Miss Orcutt.

Apr. 3, 1925-

Executive meeting

Executive met with the Sec. It was decided that it might be well to suggest to the road supervisor that a report from him on the work whole of the work already done by Willie Walker in payment for the \$1.80 would be acceptable, also the amount still due to complete the payment.

It was reported that orders on the Treas. favor of Mr Linder for making out deeds and mortgages for the C.G. Society to the amount \$1.00 had been drawn. Another bill of \$5.00 awaits the action of the Com. has been approved by the Com but the order not yet drawn.

It was decided to recommend to the C.G. that it do not approve the sale of the land on which Mr. Ester has 5-years lease for his garage. It being part of the street and park system should not be permanently disposed of.

Apr. 8, 1925-

Ex meeting. all present.

It was agreed to draw orders on the treasury for the amounts of all bills presented that had been passed by the C.G. or O.K'd by the road supervisor. This does not include Mr. Buckland's bill which had been presented at a previous

meeting and laid on the table.
Ex. can do nothing with the bill
unless the C. G. takes it from the
table and returns it to the Com.
It was agreed to give Mr.
Thornton authority to investigate
the matter of the C. G. College
lands as per the C. G. vote.

Apr. 29, 1925

Two members present.
Mr. Wheeler brought before the
Com. three applications for permits.
One for permit to build and
operate a power laundry, to be
known as the Ruskin Community
Laundry. Another for permit
to build and operate a gasoline
service station on his lot at the
corner of 4th & Pearl St.:-

The third would call for a
franchise for putting in an
electric light plant. The Ex
recommends that Mr. Wheeler
be granted the first two
permits, and that a Com. be
chosen to go into the matter of
the electric lighting plant with
Mr. Wheeler with a view to
accepting the proposition if the
terms and condition be found
upon further consideration to
be reasonable and just.

May. 15, 1925-

Executive Com. reports having drawn orders on the treasurer in favor of Harry Spencer for \$81.50, of which \$5. was in the former bill in which Mr. Spencer asked for lot 190. and \$76.50 in bill rendered Apr. 22.

Executive also reports drawing order on the treasurer in favor of the Homebuilders, in the amount of their bill \$36.54.

Trustee meeting, June 5, 1925.

Executive meeting called but only one member of Ex present.

Trustee meeting followed. Bill of Mr. Linder for \$1.50 for making two deeds and a mortgage presented. Pay for making deeds allowed. Party making the mortgage should pay for same.

Executive July 3, 1925-

Two members met at 7.30 and discussed some matters to present at trustee meeting

Trustee meeting 8 P.M.
Five trustees present

Matter of bridges discussed. Mr. Thornblom agreed to see Road Com. Hillians about the bridge across the ditch from 4th St. on Emerson Ave, since it was his heavy machines that broke it down. As there is not funds at present

and the bridge is not greatly needed it was decided not to recommend the bridge on the boulevard below Capt Dickmans at present.

Mr. Webster's petition for permit was discussed and it was decided to get more information before recommending it. Common ground land was discussed, and it was agreed to recommend that the C.G. have an abstract made of the C.G. land, as it is believed that there are more lands belonging to the C.G. than shown on any of our lists.

Mr. Thornton reported that two lots thought to be C.G. have found an owner. He had been notified that he should call for his money.

Executive Dec 3, 1925

Agreed that Mrs. Lilly should have another farm tract in place of the one already deeded. To instruct road supervisor to put in bridge across big ditch by Mrs. Long's place. To recommend that bridge should be built on blvd. below Capt. Dickinson's. Discussed road work and how to get grading done at least expense. Recommend that Mr. McHargue's offer of \$25 for triangular lot between his lot and blvd. Bridge needed to Mr. Currys?

Ex. Dec, 31.

No one present. Bill for road work had been handed the Sec. On Jan 1st, it was agreed by phone that order for amt \$40 should be drawn on treas favor of Geo Dill. Bill had been O.K'd by road supervisor.

Com.

The matter of the
North Central Ave. ditch
was discussed, and

Mr. Dickman came
before the Com. and requested
that 6th St. be improved
among the first work to
be done on streets.

It was brought out that
this work had already been
authorized to be done as
soon as funds are avail-
able.

The matter of the Building Permit lease to the 20th Century Club of a site on the Park on South side of Bieskin Inlet, and just East of 4th St. was taken up.

In as much as this Park was in front of the home of Mr & Mrs Ames, they had been invited to consult with the Committee, in the matter

Mr Ames stated that while ^{he} would really prefer not to have a building put up on the Park but that since it had been authorized by the C. S. Society, requested that it be placed so as not to obstruct the view of the water-front from his home.

He was assured that this was the sense of the Committee, and the following motion was made by Paul B Dickman and adopted:

That the rear of the building shall not extend more than 75 ft. from the 4th St. line, and that neither side of building have an unsightly appearance; but that all sides present, as near

practical, a "Front"
appearance.

Also that this Build-
ing Permit Lease does
not interfere in any
way to the free use of
of the Park or water
front to any citizen of
Ruskin.

After a general dis-
cussion, Committee
Adjourned.

acct of fill put in for
road. As they had
agreed to do this in
the first place, in con-
sideration of Right of
way across this prop-
erty.

In discussing the
N. Central Ave. ditch,
Paul B. Dickman offered
to take his tractor & plows
and grade up Central
Ave. making ditch as
deep as possible in

tractor, and wait
for his pay until
the C. & S. Society got it,
provided others would
clear the right of way
of all trees, stumps and
palmettoes.
