

# GEORGE the Third by the Grace of God,

of Great-Britain, France and Ireland, King, Defender of the Faith, and so forth, and in the Year of Our Lord, One Thousand Seven Hundred and Sixty-Eight and in the Eighth Year of Our Reign.

To all to whom these Presents shall come Greeting:

WHEREAS by Our Commission under Our Royal Sign Manual after reciting That in Pursuance of the Ninth Article of the Definitive Treaty of Peace concluded at Paris the Tenth Day of February One Thousand Seven Hundred and Sixty-Three the Islands of Grenada and the Grenadines were ceded to Us in full Right and the Partition of the Islands called the Neutral-Islands was agreed and fixed so that those of St. Vincent Dominica and Tobago remained in full Right of GREAT-BRITAIN and had since such Cession by Treaty become the Royal Patrimony of the Crown of Great-Britain and as such remained to be given granted sold or disposed in Fee for Lives Terms of Years or such other Estate or Interest as we should think fit to grant therein WE did nominate constitute and appoint our trusty and well beloved William Young Alexander Graeme John Hunt Robert Stewart and Robert Wynne Esquires to be our Commissioners for the Selling and Disposing of the said Lands in the said Islands according to Instructions under our Sign Manual and in Case of the Death or Absence of any of them or their Refusal or Neglect to execute the Power given and perform the Trust in them thereby reposed WE did thereby authorize direct and empower any Three of them to execute all the Powers Trusts and Authorities therein contained as fully and effectually as all the said Commissioners might or could do AND WHEREAS the said Alexander Graeme being dead We did by our subsequent Commission under our Sign Manual also nominate constitute and appoint our Trusty and well beloved William Hewitt Esq; One of our Commissioners for executing our said Commission with the same Powers and Authorities as were granted by our said Commission to any other of our said Commissioners AND WHEREAS by our said first mentioned Commission We did Command our Governor in Chief of the said Islands and all other our Governors Lieutenant-Governors Commanders in Chief Officers Ministers and other our loving Subjects whatsoever to be at all Times aiding and assisting to our said Commissioners in the Execution of our Commission AND WHEREAS by our said Instructions to our said Commissioners We did empower them to Sell and Dispose of certain Lands in our said Islands in the Manner by our said Commission and Instructions mentioned after reciting that as exact Surveys should be made with all possible dispatch as the Nature of the Ground and other Circumstances would allow of the several Islands the Objects of our Commission so far as the same had not been surveyed to their Satisfaction AND in Conjunction with the Governor-General of the Grenades and Neutral-Islands or the Commander in Chief for the Time being or in his Absence in Conjunction with the Lieutenant-Governor of the Island in which they should be immediately employed should divide the Islands of Tobago and St. Vincent into Parishes of such Extent and Boundaries as therein mentioned and should set - a - part proper Lands in convenient Situations for Fortifications Yards for the Use of the Navy and other Military Purposes and that our said Commissioners should determine on a proper Situation adapted to and convenient for Trade and Navigation in every Parish or a Town and should reserve in every Parish a certain Number of Acres of Wood-Land in the most Mountainous Parts for Preservation of the Seasons and answering several other publick and private Purposes That they should trace out great Roads of Communication between Town and Town in each Island And that after such Reservations they should lay out the Remainder of the Land in each Parish in Allotments for Plantations consisting in the Islands of Grenada Tobago and St. Vincent of not less than One Hundred nor more than Three Hundred Acres in general with a sufficient Number of Lots in proper and convenient Situations of Four or Five Hundred Acres each and in the Island of Dominica consisting of not less than Fifty nor more than One Hundred each in general except in such places as should appear Commodious for Sugar Plantations where the Allotments might be of three Hundred Acres such Allotments to be made exclusive of Lands to be reserved for Poor Settlers The Lands that belong to French Proprietors in the Island of Grenada at the Time of its Capitulation and of the Lands in the Islands of St. Vincent and Dominica which were in the Possession of French Inhabitants at the Time of the Surrender of those Islands and are still in their Possession And that our Commissioners should dispose of the Lands in any of the Islands which were the Objects of our Commission by Publick Sale to the best Bidders in such Lots as were therein above described and that the same should be put up to Sale at a Price not less than Five Pounds Sterling per Acre of the Lands that were cleared and if the Lands were uncleared at a Price not less than One Pound Sterling per Acre That previous to the Sale Public Advertisements giving Notice of the Time and Place of Sale Number of Plantation-Lots Town and Pasture-Lots intended for Sale and the Conditions of Sale and Time of Payment of the Purchase-Money should be published and we did direct our Commissioners to declare the best Bidder of every Lot to be the Purchaser who should thereupon pay down Twenty per Cent of the Whole Purchase - Money and Six Pence Sterling for every Acre of which the Lots should consist for the Expence of surveying the same And that they should immediately give to such Purchaser a Bill of Sale of the Lot so by him purchased and a Certificate of his being the best Bidder and that upon producing such Bill of Sale and Certificate to our Governor-General of the Grenades and Neutral-Islands or Commander in Chief for the Time being he should be entitled to a Grant in Fee-simple of the Lands by him purchased under the Seal of the Islands upon the

the Conditions therein (that is to say) in the first place over and above the Twenty Pounds per Cent of the whole Purchase Money he should pay down Ten Pounds per Cent of the whole Purchase Money within One Year from the Date of such Bill of Sale Ten Pounds per Cent more within the Second Year after the Date of such Bill of Sale and Twenty per Cent within every successive Year until the Whole was paid and in Default of any of the said Payments for the Space of Two Months that the Lands should be forfeited and that our Commissioners should sell the same and out of the Money arising from such Sale retain as much as was due to us and apply the Residue for the Benefit of those who may have advanced Money on the Security of the said Lands and if any Surplus remains after discharging such Demands the same should be distributed among his other Creditors and the Residue paid to himself or his Representatives That in the next place the Purchaser might under such Grant immediately take Possession of the Lands purchased but that such Grant should in Case of Fraud Collusion or other Contravention to our Instructions be revocable for the Space of Twelve Months from the Date of such Grant by our Lord High Treasurer or Commissioner for our Treasury for the Time being but if not revoked within the said Term should be absolute and if revoked Notice thereof should be immediately transmitted to our Commissioners and that they should on receiving such Notice direct the Money paid to be returned with the usual interest of the Land with a Compensation for the Money that he may have laid out in clearing improving and building on any Part of the said Lands to be ascertained by Arbitration as is directed in case of Lands taken from the French Inhabitants and the said Lands should be again exposed to Sale That no Purchaser should be seized in his own Name or Names of others in Trust for him of more than Five Hundred Acres in the Islands where the Lands lie and if in the Island of Dominica of more than Three Hundred Acres and if so seized of a greater Number including those comprised in the said Grant that the Purchase and Grant of so many as should exceed that Number should be void and a proportionable Part of the Money paid thereon forfeited and the Lands resumed and again exposed to Sale That if the Lands are cleared a Condition should be inserted in the Grant that within Three Months from the Date of the Grant the Purchaser should settle and afterwards constantly keep on the Lands One White Man or Two White Women for every Hundred Acres or be liable to a Penalty of Twenty Pounds per Annum for every White Woman and Forty Pounds per Annum for any White Man who should be wanting That the Purchaser should be subject to the Payment of an annual Quit-Rent of Six Pence per Acre Sterling to begin from the Date of the Grant under a Penalty of Five Pounds Sterling for every Acre the Quit-Rent for which should be left unpaid And if the Lands are uncleared a Condition should be inserted in every Grant that from and after Six Months from the Grant One Acre in Twenty should be cleared for every Year until Half the cultivable Lands shall be cleared under the Penalty of Five Pounds Sterling per Annum for every Acre not cleared and that the same Condition of keeping One White Man or Two White Women should be obligatory on the Purchaser of uncleared as well as cleared Lands and should pay a Quit-Rent of Six-Pence Sterling for every Acre as the same should be cleared And we did thereby give Directions for the Disposal of Town and Field-Lots and reserved to us all Mines of Gold and Silver which then were or thereafter might be discovered as by our said Instructions which are recorded in the Secretary's Office of our Island of Grenada may more fully and at large appear AND WHEREAS our Lords of the Treasury have by a Second Set of Instructions to our said Commissioners dated the Sixth Day of December in the Year of our Lord One Thousand Seven Hundred and Sixty-Four and in the Fourth Year of our Reign given further Directions concerning the Leases to be made to the French Settlers in the Islands of Dominica and St. Vincent with respect to the making them Compensation for Buildings on their giving up their Lands and to the restraining them from selling or alienating their Leases without Licence and to their Residing at least Half a Year in the Islands where the Lands lie And that the Town and Field-Lots that may be Sold or Granted are not to be comprehended within the limited Number of Acres for Plantation-Lots in each Island And that the Commissioners might sell to any one Person Ten Town-Lots and not more but the Governor should grant but One Town-Lot of uncleared Land to any one Person That a further Term of Six Months should be allowed to Purchasers for the clearing of Five Acres of Land on every Hundred in all Cases where no Fraud or Collusion is suspected and the Confirmation of the Grants have been delayed by any Accident or Objection beyond Six Months from their Date That the Quit-Rents were extendible to the whole of every Purchaser's Lands as they shall become cleared and also expressing their approbation that Bonds should be taken by the Receiver from the Purchasers to pay the Instalments of their Purchase-Money at the Terms directed AND WHEREAS by our Royal Proclamation given at St. James's the Twenty-Sixth Day of March in the Year of Our Lord One Thousand Seven Hundred and Sixty-Four and in the Fourth Year of our Reign We did declare that we had taken into our Consideration the great Benefit which would arise to the Commerce of our Kingdom and the Interests of our Subjects from the speedy Settlement of our Islands Grenada the Grenadines Dominica St. Vincent and Tobago and therefore thought fit with the Advice of our Privy-Council to issue that our Royal Proclamation to publish and declare to our loving Subjects that we had with the Advice of our Privy-Council given the necessary Powers and Directions for an immediate Survey and Division into proper Parishes and Districts of such of the Islands as had not been surveyed and divided and for laying out such Lands in the said Islands as were in our Power to dispose of into Allotments for Plantations of different Size and Extent and into Town-Lots Pasture-Lots and Lots for Poor Settlers and did give Directions also for making Leases to the former French Proprietors in Dominica and St. Vincent and that the several Allotments when laid out should be set up to Sale at a Price by the Acre to be fixed by our Commissioners appointed for that Purpose And the Lands so set up to Sale by Auction should be sold upon the Terms and under the Reservations and Conditions therein and in our said Instructions particularly set forth and as by them and our said Proclamation may more fully and at large appear AND WHEREAS we have by our said Instructions to our said Commissioners directed that the Purchaser producing his Bill of Sale signed by them with a Certificate of his being the best Bidder should be sufficient to entitle such Purchaser to a Grant from our Governor-General under the Seal of our said Islands AND WHEREAS by a certain Bill of Sale made at Tobago the Twelfth day of May in the Year of our Lord One Thousand Seven Hundred and Sixty-Six and in the Sixth Year of our Reign by Three of our Commissioners viz. William Young Robert Stewart & Robert Wyman Esquires after reciting that in Pursuance of their Instruction to them by us given bearing Date the Twenty-Fourth Day of March One Thousand Seven Hundred and Sixty-Four and in the Fourth Year of our Reign They did put up to Public Sale in the said Island of Tobago two certain Plantation Lots or parcels of land situate lying & being in the Great River Division of the said Island of Tobago

distinguished by the Denomination of Lots Number Two & Three of Great River Division Containing Five Hundred Acres  
 of Wood Land of such Boundaries & Descriptions as by Plans of the said Lots or parcels of Land thereunto annexed might appear And  
 after reciting that Alexander Brown of the said Island of Tobago Lieutenant Governor did bid at such Sale the sum of One hundred  
 Sterling per Acre for the said Five Hundred Acres of Wood Land the purchase Money amounting in the whole to the sum of Five Hun-  
 dred pounds Sterling They did declare the said Alexander Brown the highest Bidder Therefore in consideration of the sum of One  
 hundred pounds Sterling being Twenty per cent on the whole purchase Money by him the said Alexander Brown to William Young Esquire  
 our Receiver of the Monies arising from the sale & disposal of Lands paid and also in consideration of the remainder of the purchase Money  
 to be paid at the time and in the manner theremore mentioned and for the purpose of entitling the said Alexander Brown to a Grant in  
 Fee simple of the said Plantation under the Great Seal of our Islands They the said last mentioned Commissioners did by the said recited  
 Bill of Sale as far as in them lay convey unto the said Alexander Brown all those two Plantation Lots or parcels of Land therein particular-  
 ly described to be held to the said Alexander Brown his Heirs and Assigns forever upon the Terms and under the Reservations Conditions &  
 Penalties in the said Bill of Sale expressed and in pursuance of our said Instructions to them given which said Terms Reservations  
 Conditions and Penalties are hereinafter in this our Grant particularly expressed and they did certify on the back of the said  
 Bill of Sale that the said Alexander Brown was the purchaser of the said ~~Lot~~ Land therein Conveyed and that the first Twenty  
 per Cent of the whole purchase Money had been paid to our Receiver And Whereas since the making of the said Bill of  
 Sale to wit on or about the Ninth day of July in the year of our Lord One Thousand Seven Hundred & Sixty six the said Alexander &  
 Brown departed this life having first duly made & published his last will and Testament and thereby appointed the Rever-  
 end John Brown Minister of the Gospel at Rhyne in North Britain and Thomas Brown of Braven Street in the  
 City of London Wine Merchant Devisees of his Real and personal Estate and Executor of the said Will And  
 Whereas the said John Brown and Thomas Brown have since the Death of the said Alexander Brown for a valuable  
 Consideration sold their Right and Interest in the said Lots of Land and premises to John Graham of the  
 Island of Grenada Esquire as by the Conveyance thereof lodged in the Office of the Clerk of the Patents of  
 the said Southern Charibbee Islands may more fully appear And Whereas the said Bill of Sale with the Certi-  
 ficate required has been produced to our Captain General and it appears to him by the said Certificate on the said  
 Bill of Sale endorsed that the said Alexander Brown was the purchaser at the price therein mentioned and that  
 the sum of One hundred pounds Sterling being Twenty per cent on the whole purchase Money had been paid  
 to William Young Esquire our Receiver of the Monies arising from the sale and disposal of our Lands in our said  
 Islands And Whereas the said John Graham in consequence of such his purchase and of his having produced  
 the said Bill of Sale & Certificate together with the said Conveyance of the said John Brown & Thomas Brown  
 hath applied to our trusty and well beloved Robert Melvill Esquire our Captain General & Governor in Chief  
 in and over our said Southern Charibbee Islands of Grenada the Grenadines Dominica S. Vincent & Tobago in  
 America Chancellor Ordinary & Vice-Admiral of the same, for a Grant of the said Lands in the said Bill  
 of Sale ~~described~~ and hereinafter described And being desirous of carrying our gracious purposes into execution  
 with all possible expedition for the encouragement of our loving Subjects who may become purchasers  
 of our Lands and for the speedier population Settlement & establishment of our said Islands Now know  
 ye That having a confidence in the Loyalty and good affection of the said John Graham towards us and our  
 Government of our especial Grace certain knowledge & mete Motion and by and with the advice and  
 consent of our said Captain General Robert Melvill Esquire for us our Heirs & Successors Have given and  
 granted and by these presents for us our Heirs and Successors do give and grant unto the said John Graham  
 his Heirs and Assigns the said Two Plantation Lots or parcels of Land situate lying & being in Great River  
 Division in our Island of Tobago and distinguished by the Denomination of Lots Number Two & Three
